# CONDITIONS OF ENTRY HARRY STYLES



#### Stadium Rules:

- Juveniles under 16 years must be accompanied and supervised by a responsible adult (as defined by Section 125(2)(b) of the Liquor Control Act 1988) in order to enter and remain at the event. All patrons must provide photo ID upon request by the venue
- Camping on the venue property is strictly prohibited, staff will be onsite to monitor this and ask you to move on, and if required refuse entry
- Unauthorised entry to the venue is strictly prohibited. Penalties under the Criminal Code Act 1913 (WA) s 70A(2), which states, '[a] person who, without lawful excuse, trespasses on a place is guilty of an offense and is liable to imprisonment for 12 months and a fine of \$12,000'
- Handbags or small bags up to A4 in size (30cm x 20cm) will be permitted. Backpacks or large bags are prohibited
- Bags and patrons may be subject to a search
- Bags and other belongings must be stored underneath a venue seat or a on a patrons lap
- Cameras (including digital cameras), audio and video recorders may only be brought into the Stadium at the discretion of Stadium Management (VenuesWest). In general, cameras with a lens larger than 200mm are not permitted and must be cloaked
- No pass out event
- Smoking is only permitted in the designated smoking area located inside the venue
- Tickets must be retained and are required to be produced upon request.
- Patrons are not permitted to transmit, broadcast, sell, license or otherwise publish, disseminate or reproduce any recordings of an event without the prior written approval of VenuesWest
- Unauthorised advertising or promotional material including merchandise.
- Patrons are not permitted to sell goods or services at the Stadium without prior written approval from VenuesWest
- Deliveries from external caterers are not permitted into the Stadium.
- Patrons must comply with all reasonable requests from VenuesWest

### Patrons are <u>prohibited</u> from bringing into HBF Park the items listed below:

- Alcoholic beverages
- Plastic PET bottles over 600mL (if under 600mL must be sealed or emptied)
- Illicit drugs
- Handbags or small bags up to A4 in size (30cm x 20cm) will be permitted. Backpacks or large bags are prohibited
- iPads or tablets
- Selfie sticks
- Aluminum cans (including sunscreen cans sunscreen stations provided at venue)
- Glass and metal bottles
- Cameras with a detachable lens or lens larger than 200mm (including digital cameras) or GoPros
- Audio and video recorders
- Banners must be no larger than A1 (59.4cm x 84.1cm), no poles permitted
- Flags must be no larger than 1m x 1m, poles are not permitted
- Eskies

## VenuesWest and the Licensee's rights include but are not limited to the items listed below:

- VenuesWest or the event promoter may use a patrons image as part of any event recording and patrons consent VenuesWest or the promoter to do so
- VenuesWest or the event promoter may film a patron as part of CCTV security footage or during an event recording and patrons consent VenuesWest or the promoter to do so
- VenuesWest takes no responsibility for any lost or stolen items
- VenuesWest takes no responsibility for personal injury to any patrons
- Patrons entering HBF Park enter entirely at their own risk
- The Standard Conditions of Entry will remain in force and be applied in conjunction with current government restrictions

## For your safety and comfort, HBF Park management (VenuesWest) reserves the right to refuse entry or evict patrons displaying unacceptable patron conduct including but not limited to:

- Patrons under the influence of alcohol or drugs
- Patrons displaying disorderly or inappropriate behaviour
- Patrons who are offensively attired or whose attire may cause a hazard or compromise safety
- Patrons with damaged tickets or without ID if concessional tickets have been purchased
- Patrons who fail to follow the instructions of HBF Park personnel or who interfere with security procedures
- Patrons who refuse bag and patron checks
- Patrons attempting to take alcoholic beverages outside stadium licensed areas
- Patrons who cause damage of any kind to Stadium property
- Patrons smoking within any part of the stadium (excluding the dedicated smoking areas that will be signed)
- Patrons entering the field or any other unauthorised area as an unauthorised person
- Patrons failing to produce a ticket upon request
- Patrons selling goods or services at the Stadium without prior written approval from VenuesWest
- Patrons refusing to comply with all reasonable requests from VenuesWest

- Umbrellas
- Strollers and prams
- Flares or fireworks
- Musical Instruments including loud hailers, vuvuzelas or air horns
